Acknowledgment of Risks Agreement:

In CONSIDERATION of the services provided by Pinnacle Pursuits Inc. their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as Pinnacle Pursuits) it is hereby UNDERSTOOD and therefore I AGREE to release, indemnify, and discharge Pinnacle Pursuits Inc., on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

- 1) I acknowledge, that my voluntary participation in any and all educational and outdoor adventure based activities such as, but not limited to, hiking, archery, raft building, canoeing, climbing wall, orienteering, rappelling, high ropes & low ropes challenge courses, shelter building, survival skills, sports and games, as well as various leadership initiatives and team-building challenges entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activities or the event.
- 2) I expressly agree and promise to accept and assume all of the risks existing in these activities. My participation in these activities is purely voluntary, and if there is something I do not feel comfortable with, I will choose not to participate. I will inform Pinnacle Pursuits staff of any physical injuries, medical concerns, allergies, or emotional fears and phobias that may impact my involvement in today's program.
- 3) I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Pinnacle Pursuits and any land-owners or building-owners, on or in which these activities take place, from any and all claims, demands, or causes of action, which are in any way connected with my participation in these activities.
- 4) Should Pinnacle Pursuits or anyone acting on their behalf, be required to incur lawyer's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
- 5) I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else agree to bear the costs of such injury or damage myself. I am completing a medical form with Camp Goodtimes that details any medical or physical conditions that I have in case an emergency does arise where such information is necessary to help deal with the health issue. Camp Goodtimes will keep this on file during camp and it will stay fully confidential.
- 6) In the event that I file a lawsuit against Pinnacle Pursuits, I agree to do so solely in the province of British Columbia, and I further agree that the laws of that province shall apply in that action without regard to the conflict of law rules of that province. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
- 7) I have had sufficient opportunity to read and understand this entire document. I have read it, and I agree to be bound by its terms.
